## KHYBER PAKHTUNKHWA PUBLIC SERVICE COMMISSION

### MEMORANDUM

#### MR GOVERNOR

The Khyber Pakhtunkhwa Public Service Commission is pleased to submit its annual report for the year 2018 as required under Section 9 of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978.

2. During the year 2018, the Commission received requisitions for selection against **2850** posts from various departments of the provincial government (**Appendix-A**). **3164** posts were carried over from the year 2017.

3. The Commission conducted tests/ examinations and interviews and made recommendations **4355** candidate to the Government for appointments against the advertised posts (**Appendix-B**). Due to non availability of eligible candidates **396** posts could not be filled in (**Appendix B & C**).

4. Recommendations of the Commission are normally implemented within 1-3 months and the recommendees get their appointments from Government Department. Recruitment cases wherein recommendations of the Commission have been delayed beyond three months are reflected at **Appendix-D**.

4. During the period under report, **305** cases of litigation were subjudice in various courts including 19 cases in the Supreme Court of Pakistan, 157 cases in the Peshawar High Court and its Benches, 18 cases before the Khyber Pakhtunkhwa Service Tribunal, 07 cases before Provincial Ombudsman

Secretariat and 07 cases were pending with the subordinate Civil Court. Details are at **Appendix-E**.

5. As already intimated in the report of the preceding year, a number of posts are repeatedly advertised but could not be filled due to non availability of eligible candidates from particular zones and areas. Due to non availability of a substitution policy, the positions cannot be allocated to other zones. There needs to be a policy that if a post is advertised two times for a particular zone and eligible candidates are not available then the post for the third time may be advertised for merit.

6. Revision of zonal allocation and readjustment of areas for distribution of seats has been a demand since long. Since census 2017 has now taken place, a High level Commission, to be constituted, may reconsider the zonal allocation especially in the wake of merger of FATA into Khyber Pakhtunkhwa.

7. The marking system in respect of non-syllabus based recruitment is regulated by Regulation 28 of Khyber Pakhtunkhwa Public Service Regulations, 2017. The PSC revised the marking system of non-syllabus based recruitment in pursuance of the Cabinet decision dated 06.09.2017 which is as follows:-

8. The Commission feels that disproportionately higher marks have been allotted to screening test. Screening tests are based on multiple choice questions. Candidates having expertise of cramming can secure higher marks than those with creative minds, scholarly approach, in depth knowledge and aptitude. There is need for equal distribution of marks between Academic Record, Screening Tests and Interview.

9. As reiterated in the report for the preceding year, the Commission suggests that the ratio of marks may be as follows:-

10. There is gap and enormous disparity in the standard and marking of various universities. As reiteration of the preceding year report, the Higher Education Commission and the Higher Education Department should play its due role to bring uniformity in syllabi and marking of various universities.

11. The Commission confronts the issue of its inability for making on the spot payment to paper-setters, supervisory staff for examinations, logistic arrangements to conduct examinations, examiners for checking the papers, remuneration for advisors and allied expenditures. Payment of remuneration is made from head of account "A-03919-Payment to Others for Services Rendered" wherein the Commission needs to be provide lump sum funds of Rs.30 million at the commencement of the financial year with the Finance Department approval for advance sanction so that before commencement of examination the PSC

could get the amount through AG Khyber Pakhtunkhwa and made on the spot payment to the advisors and Invigilating staff of various examinations.

12. Keeping in view the annual price hike, the Federal as well as Provincial Governments enhances salary of Government Employees on annual basis. No enhancement in pay and allowances of the Chairman and Members, KP Public Service Commission has been made since March 2015. There needs to be a mechanism that at least 10% annual enhancement in salaries of the Chairman and Members is made on regular basis.

13. The Public Service Commission have no colony of its own. Recently, the amendment in the Khyber Pakhtunkhwa Provincial Buildings (Management, Control and Allotment) Act, 2018, employees of the PSC have been excluded from allotment rights and those already residing in Government Accommodation were evicted. It is suggested that a scheme for construction of a colony consisting of 200 – 300 flats with multi storey grand Examination Hall for PSC Examinations may be included in the ADP. Administration Department may take necessary action in this regard.

14. The Commission is thankful to the Governor Khyber Pakhtunkhwa and looks forward to his continued help and guidance.

During the year under report Prof: Dr Yar Muhammad completed his tenure as Members PSC on 23.09.2019 and Mr Hifzur Rehman resigned with effect from 10.08.2018. 2. The appointment, promotion and transfer of the officers and staff of the Commission continued to be regulated under the Khyber Pakhtunkhwa Public Service Commission Officers and Servants (Terms and Conditions of Service) Regulations,

1985 framed under Section 3(2) (b) of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978. Strength of the Officers and Staff of the Commission, during the year, is available at **Appendix F**.

## **FUNCTIONS OF THE COMMISSION**

3. As per Section 7 of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 read with Rule 3 of the Khyber Pakhtunkhwa Public Service Commission (Functions) Rules, 1983 the Commission shall perform the following functions:-

- a. Conduct tests and examinations for recruitment of persons to:-
  - i) the civil services of the Province and civil posts in connection with the affairs of the Province in basic pay scales 16 and above or equivalent; and
  - ii) posts in basic pay scale 11 to 15 or equivalent in all Administrative Departments and Attached Departments of the Government except the District cadre posts and the posts of Junior Clerk BPS-11.
- b. To advise the Governor: -
  - i) on matters relating to qualifications for, and method of recruitment to, services and posts referred to in clause (a)
  - ii) on the principles to be followed in making;
    - 1. initial appointments to the services and posts referred to in clause (a);
    - 2. appointment by promotion to posts in BPS-17 and above; and
    - 3. transfer from one service to another; and
  - iii). any other matter which the Governor may refer to the Commission.

## **CASES OF LITIGATION**

7. During the period under report, the Commission was made party in 208 cases of civil litigation wherein 19 cases were subjudice in the Supreme Court of Pakistan, 252 in the Peshawar High Court and its Benches, 18 before the KP Service Tribunal, 09 before Provincial Ombudsman and 07 cases were pending with the subordinate Civil Court. Details are given in **Appendix E**.

8. During the year under report, \_\_\_\_\_ cases were decided in favour of the Government/ Commission and \_\_\_\_\_ in favour of candidates. The plea of candidates in majority of the cases decided in favour of the Commission was \_\_\_\_\_ (low merit in test or interview). The cases that were decided in favour of candidates pertained either to flaws in service rules or regularization or over-age factor or less experience etc. The litigation cases cause extraordinary delay in recruitment process, therefore, the Government Advocates needs to play their due role in defending cases against Government and the Departments to provide every assistance of required proofs to the Government Pleaders / Advocates for meaningful arguments in the courts of law.
