RECRUITMENT

KP PSC finalized recruitment for 411 different posts in various provincial Departments in the Quarter wherein 306 candidates recommended to the government for appointment after interviewing 1371 candidates making the target 74% achieved. Due to unavailability of eligible candidates, 105 posts remained leftover in which 86 pertained to Health Department. Higher Education Department was proved a big client for the Commission where recommendations of 146 Lecturers were finalized. Other details are as follow:-

RECRUITMENT AGAINST SPECIAL QUOTA

KP PSC recruits Female, Minority and Disable candidates against both general and reserved quota of 10, 5 and 2 percent respectively. During the Quarter under report, female candidates occupied 27 posts in general quota and 13 posts from reserved quota. Out of 104 reserved posts for minorities, only 10 posts were filled and 94 remained unfilled for want of eligible candidates.

RECOMMENDATIONS FOR THE POSTS OF PMS (IN-SERVICE QUOTA)

The Commission finalized recommendations of 35 candidates of Provincial Management Service (In-Service Quota). The written exam was conducted in the 1st week of September, 2021. Out of 256 candidates only 155 candidates appeared. The result was announced on 12th January, 2022. Forty two candidates qualified the written exam. The Psychology Wing assessed the

qualified candidates through Aptitude Test, Group Discussion and Individual Interview in the area of intellectual level, emotional stability, competency, will power and leadership qualities in February, 2022. Final result of recommended candidates announced on 21st March, 2022.

RECOMMENDATIONS FOR THE POSTS OF CIVIL JUDGES-CUM-JUDICIAL MAGISTRATE

The Commission recommended 72 candidates Including 27 female for the posts of Civil Judges-cum-Judicial Magistrate to the Government for appointment. 12 posts remained vacant due to non availability of eligible candidates.

COMPETITIVE EXAMINATION FOR THE POSTS OF PROVINCIAL PLANNING SERVICE (PPS)

The Commission conducted competitive exam for 10713 candidates for the posts of Provincial Planning Service (PPS) from 22 to 25th March, 2022. To facilitate candidates, 41 exam halls were reserved for Male and 9 for Female candidates in divisional head quarters. Total 2772 or 26% candidates appeared in the examination. Other detail is as under:-
