## WRITTEN EXAMINATION FOR PROVINCIAL MANAGEMENT SERVICE (PMS) 2022

The Khyber Pakhtunkhwa Public Service Commission successfully conducted written examination for the posts of Provincial Management Service Officers (BPS-17) for 33457 candidates with effect from 4<sup>th</sup> October 2022 to 22<sup>nd</sup> October, 2022 at all divisional headquarters of Khyber Pakhtunkhwa. For this exam., the Commission had to hire 118 examination halls, including 42 examination halls of Public & Private Colleges / universities. Conducting of full competitive examination for such huge candidates with meager human resource and financial constraints was indeed a gigantic task for KP PSC. However, the task became possible with the Provincial Government support and sponsorship. The Commission extends its gratitude to Provincial Government and looks forward for similar support and assistance in future.

## COMPLETION OF TENURE OF HONOURABLE MEMBER

During the quarter under report, Prof. Dr. Muhammad Nawaz completed his tenure as Member PSC on 14<sup>th</sup> November, 2022. He rendered invaluable services since joining the Commission on 15<sup>th</sup> November, 2017. The Commission wished him good luck.



## APPOINTMENT OF HONOURABLE MEMBER

Dr. Tahir Nadeem Khan (Retd. BS-20 Ex. DG Health Services, Khyber Pakhtunkhwa) was appointed as Member of KP PSC. He took oath of his office on 28<sup>th</sup> November, 2022. Capt. (Retd.) Sikander Qayyum Chairman PSC administered the oath. The Hon'able Chairman and Members welcomed him in the Commission.

## MEETINGS OF THE COMMISSION

During the Quarter under report two meetings were held on 24<sup>th</sup> October, 2022 and 8<sup>th</sup> November, 2022. In the first meeting experiences and observations in PMS Exam and ways for further improvement of examination system were discussed comprehensively. Accordingly, lessons learnt were issued as guidelines for future. The Commission agreed upon to approach the Provincial Government for amendment in rules, allowing screening test before competitive exam.



## CALL ON BY CHAIRMAN, FEDERAL PUBLIC SERVICE COMMISSION ON CHAIRMAN KP PSC



Capt. Retd. Zahid Saeed Hon'able Chairman, Federal Public Service Commission alongwith Mr Akbar Hussain Durrani Hon'able Member FPSC called on the Chairman KP PSC on 26<sup>th</sup> October, 2022 and exchanged views on working of both the Commissions.

## RECOMMENDATION OF DEPUTY SUPERINTENDENT OF POLICE

The Commission recommended 6 candidates to the government against 7 posts of Deputy Superintendent of Police (BPS-17) Fast Track Promotion in Police Department after interviewing 23 candidates. It is pertinent to mention that out of total 43 eligible candidates, 23 qualified the written exam and subsequently interviewed. Six (06) candidates were recommended to the Government for appointment.

## RECOMMENDATIONS ISSUED DURING THE 4<sup>TH</sup> QUARTER

The Commission finalized recruitment against the following 1009 posts in various departments. Out of 61164 applicants, 5985 candidates were interviewed and recommendations of 918 candidates were sent to the department concerned while 91 posts remained unfilled. Post-wise details are as follows:-

## PHYSICAL TEST FOR THE POSTS OF EXCISE & TAXATION INSPECTOR

The Commission conducted Physical Test for the posts of Excise & Taxation Inspector (BPS-16) in Excise and Taxation Department for 12030 male and female candidates from 22<sup>nd</sup> November to 6<sup>th</sup> December, 2022. As per required service rules, height of male was required to be 5 feet 7 inches and chest 33 with expansion 34<sup>½</sup> and the required height for female candidates was 5 feet 1 inch only. Total 5413 candidates appeared in the test wherein 4781 candidates declared fit and called for competitive exam held on 29.12.2022 while 632 candidates were declared unfit.

## COMPETITIVE EXAMINATION FOR THE POSTS OF TEHSILDAR/ NAIB TEHSILDAR AND INSPECTOR EXCISE & TAXATION

The KP PSC scheduled competitive examination for the posts of Tehsildar/ Naib Tehsildar and Inspector Excise & Taxation from 29<sup>th</sup> December, 2022 to 3<sup>rd</sup> January, 2023. The exam: commenced during the 4<sup>th</sup> quarter and will continue till 3<sup>rd</sup> January, 2023. Total number of candidates was 11024. Attendance was 4232 (38.38%).

## COMPETITIVE EXAMINATIONS FOR THE POST OF ASSISTANT SUBINSPECTOR UNDER FAST TRACK PROMOTION AND ASSISTANT SUB INSEPECTOR TRAFFIC WARDEN IN SERVICE

The Commission conducted two written exams; one for 1685 candidates against 75 posts of Assistant Sub-Inspector (BPS-11) under Fast Track Promotion Quota and 2<sup>nd</sup> for 175 candidates against 77 posts of Assistant Sub-Inspector (BPS-11) Traffic Warden In-Service with effect from 15<sup>th</sup> to 22<sup>nd</sup> November, 2022.

In the first case, only 1009 candidates were found eligible as 676 candidates were declared ineligible while in second case, 82 candidates declared eligible and 93 candidates were rejected; mostly due to lack of the required length of experience or had not been confirmed in the rank as per service rules of the Police Department. Syllabus of the exam consisted of 6 papers including Urdu Essay, English Composition, Police Practical Work, Selected Parts of Basic Recruit Course, General Knowledge & Pak Affairs and Computer Literacy.

## RESULT OF THE COMPETITIVE EXAM: FOR THE POSTS OF INSPECTOR IN POLICE DEPTT:

The Commission announced result of written exam of 36 candidates against 50 posts of Inspector (BPS-16) under Fast Track Promotion Quota on 17.11.2022 where 15 candidates have been declared qualified for viva voce. Interview will be scheduled soon.

## RESULT OF THE COMPETITIVE EXAM: FOR THE POSTS OF SUB-INSPECTOR IN POLICE DEPTT :

The Commission announced result of written exam of 6 candidates against 50 posts of Sub-Inspector (BPS-14) under Fast Track Promotion Quota on 17<sup>th</sup> November, 2022. Unfortunately, no one qualified the written exam and posts became leftover, which will be re-advertised soon.
