MINUTES OF THE MEETING HELD ON 11.01.2023 AT 04:00 PM IN THE OFFICE OF HON'RABLE CHAIRMAN K.P. P.S.C.

A meeting was held on 11.01.2023 at 04:00 pm in the Office of Hon'ble Chairman, KP Public Service Commission. The following attended: -

- The Chairman welcomed the participants and asked the Deputy Director Admn: to explain the case. The Deputy Director Admn: stated that the case had been referred from Recruitment Wing wherein it had been proposed that the inter se seniority of recommendees of KP PSC for the posts of SET advertised in Advertisement No.1/2009 may be uploaded on the KP PSC website for the requesters who frequently request for provision of copies of the same from KP PSC under RTI Act. 2013.
- In response to a query from Hon'able Chairman, he stated that an information which is held by a department or office and not declared classified under law as the seniority list of KP PSC shall in any case have to be provided to requester on request. He stated that certain results or seniority lists such as the instant inter se seniority of SET involve 50 to 100 pages photocopies and if frequent requests are received from requesters then it becomes inconvenient for the Branch concerned to provide photocopies to each and every requester. The Director Recruitment stated that the note/ case was referred from his side. It would be appropriate to upload the same on PSC website.
- After detailed discussion and examining the pros and cons, the following decision was taken unanimously: -

"Copies of inter se seniority in old cases will be provided to the requesters on request in hard form as per RTI Act, 2013. However, merit lists/ inter se seniority of selections made from now onwards shall be uploaded on KP PSC website conspicuously in an uneditable form for information of all concerned."
