**Notification No.KPPSC/ DDA-1/0017637.** In exercise of the powers conferred by Section 10 (A) of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ordinance No. XI of 1978), the Commission is pleased to direct that in the Khyber Pakhtunkhwa Public Service Commission Regulations, 2017, the following further amendments shall be made, with immediate effect, namely:-

**AMENDMENT**

1. Regulation 21 shall be substituted as follows:-

Subject to the requisitions, Competitive / Syllabus based Examinations shall normally be held in respect of the following posts:-

- a) Civil Judge-cum-Judicial Magistrate
- b) Member of Service in Health Management Cadre
- c) Provincial Management Service (PMS)
- d) Provincial Planning Service Officer (PPS)
- e) Assistant Excise & Taxation Officer
- f) Assistant Director Local Government
- g) Drug Control and Pharmacy Service (DC & PS) Officer
- h) Tehsildar / Naib Tehsildar
- i) Assistant Sub-Inspector of Police, Traffic Warden
- j) DSP Police (Fast Track Promotion)
- k) Inspectors Police (Fast Track Promotion)
- l) Sub-Inspector of Police (Fast Track Promotion)
- m) Assistant Sub-Inspector of Police, Traffic Warden (Fast Track Promotion)

2. Regulation 25 shall be substituted as follows:-

All candidates appearing for competitive examination shall be allowed three chances for each individual examination while four chances shall be allowed in combination of competitive examinations for the posts of Provincial Management Service, Civil Judges cum Judicial Magistrates and such other posts which the Government may include in these categories of posts.
