Peshawar, dated the 29.11.2024

No.SO(Policy)/E&AD/4-4/2024---In exercise of the powers conferred by section 10 of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 (Khyber Pakhtunkhwa Ordinance No. XI of 1978), the Government of the Khyber Pakhtunkhwa is pleased to direct that in the Khyber Pakhtunkhwa Public Service Commission (Functions) Rules, 1983, the following further amendments shall be made, namely:

AMENDMENTS

1. For rule 6, the following shall be substituted, namely:

“6. Screening test.---(1) The Commission may decrease the number of candidates, on the basis of their academic record or by holding screening test in the relevant field or general knowledge, if it considers that calling all the eligible candidates for the viva voce would entail, on account of disproportionately excessive number of candidates as compared to the vacancies available or occurs an inordinate delay in concluding the process or would otherwise be counter-productive:

Provided that for short-listing of candidates for Provincial Management Service Competitive Examination, other than examination for Provincial Management Service (In-service), the Commission shall hold screening test, as specified in the **APPENDIX**, appended to these rules:

Provided further that in case of syllabus based examination, other than Provincial Management Service Competitive Examination, the Commission may hold screening test, based on syllabus of compulsory subjects or papers of the post for decreasing the number of candidates for written examination.”

2. For APPENDIX-A, the following shall be substituted, namely:

**SYLLABUS OF SCREENING TEST
FOR PROVINCIAL MANAGEMENT
SERVICE COMPETITIVE EXAMINATION**

The syllabus of the subjects, included in the screening test, is as per existing syllabus of Provincial Management Service Competitive Examination. The ratio of questions and their marks shall be as follows:

The test shall be based on Multiple Choice Questions (MCQs), Muslim candidates shall attempt the questions in Islamiat whereas the non-Muslim candidates shall attempt questions from Civics and Ethics. Passing threshold shall be 40%.

The syllabus for Civics and Ethics shall be as follows:

CIVICS:

Definition, nature and significance, state and its elements, organs of state, fundamental human rights, rights and obligations of non-Muslims under the Constitution of Islamic Republic of Pakistan, 1973. United Nations aim and objectives, main organs and agencies.


ETHICS:

Human Values: Role of family, society and educational institutions towards including universal moral values.

Integrity: Impartiality and non-partisanship, objectivity, dedication to public service empathy, tolerance and compassion towards the weak sections.

Emotional intelligence concepts and application in administration/ governance.”.
